18.91 Policies and Procedures

18.92 Consultations

Unitary – The members discussed the pro's and con's of the proposals put forward by AVDC and Bucks CC. A draft letter from the Parish Council will be circulated by the Clerk.

18.93 Roads and Transportation

Some pot holes have been attended to along London Road, but not all.

The Clerk will ask for the next cycle of maintenance in Buckland and attempt to feed in all the works that are needed.

18.94 Burial Ground

Two councillors attended a meeting with the Bucks Museum, regarding the Samian bones held by them. Currently there are 18 bodies held in the archives. BCC are insisting that the bones be kept in a 'mausoleum'. Members will consider options to have an area designated as such and costs. There are trees that are causing an obstruction to access of the Churchyard, which will be cut back. A number of graves need the mounds reducing. A letter will be sent to family members advising that the reduction would be undertaken and the ground seeded.

18.95 Grass keep, Copse and Allotments

A letter will be sent to the tenants of the allotments, giving them a 30 day grace to get the site back to how it was when tenancy was taken over.

18.96 Footpaths and Environment

AC Parish Council would be contacted to obtain details of their current project for a bridge over the canal.

A list of stiles will be presented at the next meeting.

18.97 Arla/Olleco

- Maintenance schedules had been requested and smells were ongoing. A meeting would be arranged between affected residents as to how to take the complaints forward.
- Reimbursement was agreed for meetings already held of £10. This was agreed.
- A letter would be written to David Lidington, appraising him of the situation.
- Arla have planted more trees as per their planning consent.
- 5 more units were being started
- More buildings will be applied for by august for 'lacto free' products
- Arla has offered to replace the signage in the village and these have been produced.

The web site is now live and up to date. Invoices for work done were presented and agreed.

18.99 Matters of Report

- An estate agent's sign has been placed at the end of the village.
- Cllr Tufnell attended the last RAF Closure meeting and will attend the next.
